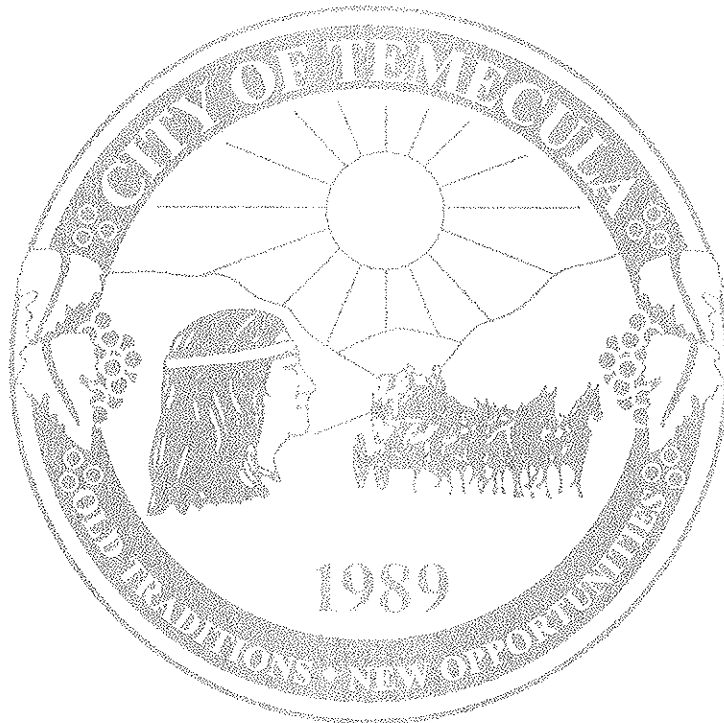

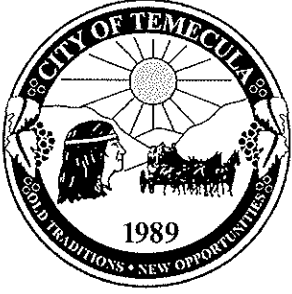

Applicants submitting construction plans for City review will need to **provide accurate square footage of landscape areas** for their project in order for the City to calculate the plan check fee when the plans are submitted. The fees specified below, include three (3) plan checks. An additional one hundred dollars (\$100) per page fee is required for all plan checks beyond the third plan check:
